This letter responds to your recent Freedom of Information Act ("FOIA") request received by the Federal Communications Commission (FCC or Commission) and assigned to the Consumer & Governmental Affairs ("CGB") Bureau. Your request seeks "all records in the CGB consumer complaint database that are designated with the active assigned code OSBC" from January 1, 2013 to present.

CGB conducted a search of the databases in which we maintain the records of informal complaints filed by, or on behalf of, consumers. Our search revealed 65 documents that are responsive to your request, which are enclosed.

Mike Hennigan of my staff redacted all personal identifying information relating to the individuals who submitted or are named in the enclosed complaints or inquiries based on Exemption 6 of FOIA, which permits agencies not to disclose files that would clearly invade personal privacy. Mr. Hennigan also redacted some FCC employee names based on Exemption 2 of FOIA, which permits agencies not to disclose internal personnel rules and practices.

Please be advised that the Commission receives many complaints and comments that do not involve violations of the Communications Act or any FCC rule or order. Thus, the existence of a complaint filed against a particular carrier or business entity does not necessarily indicate any wrongdoing by any individuals or business entities named in the complaint.

FOIA and FCC rules require the FCC to charge requesters for time spent searching for and reviewing responsive documents, and for copying them. Based on your classification as an "all other" requester, the FCC does not charge you for the first two hours of search time and the first 100 pages of copying.² Because preparing the response to your request falls within these limits, the FCC is not charging you for processing it.

Section 1464 of Title 18, United States Code, prohibits the broadcast of obscene, indecent, or profane programming. The FCC rules implementing that statute, a subsequent statute establishing a "safe harbor" during certain hours, and the Act prohibit radio and television stations from broadcasting obscene material at any time and indecent material between 6 a.m. and 10 p.m. The indecent material was broadcast within the 6 a.m. to 10 p.m. time frame relevant to an indecency determination under section 73.3999 of the Commission's rules.

For the reasons above stated, Complainant urges the FCC to exercise its responsibility to enforce the existing law against indecency on broadcast TV between the hours of 6 a.m. and 10 p.m. (Title 18, U.S. Code, Section 1464) by levying severe sanctions against the broadcasters of this program.

Complainant requests that since the broadcast television licensee willfully violated the law that it be liable to the United States for a forfeiture penalty. The legislative history to Section 312(f)(1) clarifies that this definition of willful applies to both Sections 312 and 503(b) of the Act, and the Commission has so interpreted the term in the Section 503(b) context.

I believe this constitutes "profane language" within the meaning of 18 U.S.C. S 1464 because, in context, it involved vulgar and coarse language "so grossly offensive to members of the public who actually hear it as to amount to a nuisance."

The fact that Broadcast Licensee may not have originated the programming in question is irrelevant to whether there is an indecency violation. Hold this licensee accountable for the outrageous sexual and violent content. See Review of the Commission's Regulations Governing Programming Practices of Broadcast Television Networks and Affiliates, Notice of Proposed Rulemaking, 10 FCC Rcd 11951,11961, P 20 (1995)

Complainant requests the maximum monetary forfeiture statutory penalty amount against the Licensee for broadcasting indecent material in apparent violation of 18 U.S.C. S: 1464 and Section 73.3999 of the Commission?s rules.

Complainant requests the Licensee to air future live entertainment programming with a five-minute delay to avoid future violations of Section 1464 of Title 18, United States Code.

Problem Description

According to the FCC's website, "The FCC has defined broadcast indecency as language or material that, in context, depicts or describes, in terms patently offensive as measured by contemporary community standards for the broadcast medium, sexual or excretory organs or activities." The Commission further states on the site that "...broadcasts ...that fit within the indecency definition and that are aired between 6:00 a.m. and 10:00 pm are prohibited and subject to indecency enforcement action."

This episode of 2 Broke Girls focuses primarily on one subject: Caroline's father's penis (a sexual organ), and it was broadcast at 8:30 pm EDT.

The story line is that Caroline's father is in prison. Caroline and Max visit the father in prison. During a private moment with Max, he tells her that a previous girl friend has written a book and "... the woman claims I have a small penis." On the train going home, Caroline repeatedly asks Max what her Dad told her. The scene is complicated by the fact that a small band has gotten on the train and some band members are blowing horns. Finally, Max yells out on the train, "Your Father has a small penis!?...

Later, back at the restaurant, Sophie joins the girls and lets it be known that knowledge of the penis problem is widespread. Then Oleg, the cook, says ?It came up on the Google Penis Alert! I have to keep current. See what the trends are. You don't want to be the middle aged guy who wears the same penis you had in high school!"

Toward the end of the show, Caroline and the woman accuser appear on Piers Morgan's TV news show. Caroline works hard to keep the conversation away from her Dad's penis, but Max

who has a picture of the penis on her mobile phone and she eventually gets the picture (not shown on the broadcast) in the hands of Piers Morgan. Piers says the penis is not inadequate, and decides in favor of Caroline.

Due to the penis material, the FCC should designate this episode as indecent. Why? The show, as outlined above, i) focuses on a sexual organ, ii) was broadcast and re-broadcast at a prohibited time, iii) is patently offensive and harmful, especially to children and young adults that are watching at the early evening time, and don't need to be worrying about penis lengths at their age, and iv) it is well beyond community standards in Columbus, Ohio and most of America. A key test is this: how many other TV programs or newspaper reports does an average person see about a "man's penis length"? The answer none for general consumption. The only exception might be occasionally on a health show.

One final point, this complaint should also be considered in WBNS-TV's license renewal proceeding which is currently before the Commission. See BRCDT - 20130603BEU in the Media Bureau.

And good grief, do we not understand that hormones and curiosity are natural in teens? This program was unbelievably offensive. If a teenager with a television in the game room or in their own room (and this is common in this country) were to just flip the channels, they would certainly find this program. Curiosity would be the first inclination, as it was with me (a mature adult). Once in, they would be exposed to situations that are really only the arena of adulthood and, I have to admit, I would have been exremely angry with my spouse if he had participated in frequenting a brothel. We wouldn't have stayed married, for sure. There is no responsible sexuality that is portrayed in this program. The image is purely prurient. How fun life would be in a brothel, and how lucky are those clients and employees! (That was sarcasm, but that is what you see in the images.) Please take a look at this program. Sexuality isn't a bad thing, but sexuality without responsibility is. This program should be aired, if at all, on the ADULT channels, and, in my opinion, around 2:00 a.m.

Problem Description

This is the re-filing of the complaint filed 07/09/2013 which was rejected because it was filed on the wrong form. That complaint reference number for the previous rejected complaint was 13-C00510148.

On 6/23/2013 at 6 pm, I was listening to "The Celestial News Hour" on KWCR-FM which is licensed to Weber State University in Ogden, UT. the program was hosted by "Big Jared" Christensen (KWCR General manager) and KC Austin (who may be a stage name for Austin Hatch, KWCR Program Director.) when the show took a turn for the graphic. The show contained, among other things, many references to sexual or excretory organs or activities.

The courts have held that indecent material is protected by the First Amendment and cannot be banned entirely. It may, however, be restricted in order to avoid its broadcast during times of the day when there is a reasonable risk that children may be in the audience. Consistent with a federal indecency statute and federal court decisions interpreting the statute, the Commission has adopted a rule that broadcasts that fit within the indecency definition and that are aired between 6:00 a.m. and 10:00 p.m. are prohibited and subject to indecency enforcement action. This broadcast was between 6 and 7 pm when there is an extreme likelihood that children would have been in the audience (As it was after school hours and before when children would normally be in bed.)

Highlights from this broadcast of what I believe to be indecent material are below.

In one segment the hosts discuss bedbugs. They go on to say "So, bedbugs in this country are a complete epidemic. In the late 70's, before DDT was outlawed, bedbugs were no more. Bedbugs didn?t exist in this country until the late 70's when they outlawed DDT. And then when they outlawed DDT then bedbugs just came in and are everywhere now. It?s just like, these guys, whatever. Dude, Bedbugs are crazy, they have knife-like penises, oh excuse me I shouldn?t have said that word. Units. Yeah they have Knife like units that just stab, they don't have intercourse per se, they just like straight up just stab their mate and spread it all over." Well, that?s probably what the guy in this van was thinking, right? I mean, he said it was a prank. Social experiment! That?s, you know, the next excuse I?m gonna give. I tried social norm experiments all the time when I was in college. It just backfired. Yeah, yeah, why not, its college, right? I don't know man.. So my next question is, if

he is asking this kids to help him look for his dog, is that some sort of metaphor? (Laughing)

Another example from this show of indecent content is that the hosts are discussing another story about a man that was under the influence of drugs who "ripped his own genetallia off". at one point in the story, they are talking about the police officers taking the man and the pieces of his genetallia to the hospital and one of them makes a joke about the man, when he is being put in the police car yelling at the officers "Hey, grab that tip, grab that tip" they make references to male sexual organs over and over in this story by calling it a "Unit"

Problem Description

When we selected channel 4 on our Fioptics program guide on the date/time above, the description on the guide stated that an episode of Downton abbey was supposed to be playing. Instead there was a pornographic show, with full nudity and close ups of explicit sex acts. We tried selecting other channels on the guide and returning to channel 4 to see if it returned to the regularly scheduled program, but it did not. We checked a few times within a 30 minute time frame and the pomography was continuing to be broadcast. We called Cincinnati Bell/Fioptics customer service to report it, but they gave no explanation and simply said they were surprised to hear this and would report it. The person on the phone said something like we should let WCET know about it. I did send them a message by email and they basically said they were in no way responsible, that it had to be the Fioptics system. I also sent an email to Cincinnati Bell, and just received a response today, almost 2 weeks later, asking for my account number only. The next morning after the pornography was being shown, we checked the guide again, and there was no signal/show on wcet/channel 4 at all. The channel remained blocked/blank for several days. The fact that this can occur, and such material could be accidentally viewed by children or anyone at any time is highly disturbing. Cincinnati Bell has basically shown no concern over this matter by ignoring it, and I think they need to be held accountable and required to immediately improve their safety measures to protect the general public from being exposed to this unwanted, disgusting type of programming. I hope that your organization can address the legal issues of this matter with Cincinnati Bell
