Pursuant to the Freedom of Information Act (FOIA), you are requesting "a list of (Office of Inspector General) investigations closed during calendar year 2013."

We have processed your request in accordance with the FOIA, 5 U.S.C. § 552, as amended. After a thorough search of our records and databases, we located one (1) page that are responsive to your request and it is being released to you in full.

The FOIA authorizes federal agencies to assess fees for record services. Based upon the information provided, you have been placed in the "other" category of requesters, which means you are responsible for the cost of search time exceeding two hours (\$44.00/hour) and reproduction fees (.15 per page) exceeding 100 pages.
