This responds to your Freedom of Information Act (FOIA) request dated June 3, 2014, and received in this Office on June 16, 2014 in which you requested various records concerning the Department of Justice Department Review Committee (DRC). This response is made on behalf of the Office of Information Policy.

Please be advised that a search has been conducted in the Office of Information Policy and one document, totaling eight pages, was located that is responsive to your request. This document consists of a log, including the date of receipt, of all DRC appeals and Mandatory Declassification Review (MDR) appeals that are currently under review by the DRC. I have determined that this document is appropriate for release with the names of the requesters and appellants removed inasmuch as you do not appear to be seeking this information. Please note that this log is limited to the information that has been entered into our administrative tracking system for each DRC and MDR appeal.

For your information, the DRC has no required annual, quarterly, or monthly reporting requirements. In addition, we did not locate any memoranda describing the extent of the backlog of the Committee or the average time of review completion by the Committee. Finally, please be advised that the Committee does not maintain written administrative procedures outside of those codified at 28 C.F.R. § 17.14 (2013).

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. *See* 5 U.S.C. § 552(c) (2006 & Supp. IV 2010). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.

If you are not satisfied with my response to this request, you may administratively appeal by writing to the Director, Office of Information Policy, United States Department of Justice, Suite 11050, 1425 New York Avenue, NW, Washington, DC 20530-0001, or you may submit an appeal through this Office's eFOIA portal at <http://www.justice.gov/oip/efoia-portal.html>. Your appeal must be received within sixty days from the date of this letter. If you
