SUBJECT: Freedom of Information Act (FOIA) Request

I am responding to your December 31, 2014, request that you submitted to the NASA Office of Inspector General (OIG). It was received by the OIG on January 7, 2015. You requested a list or printout of the OIG investigations closed during calendar year 2014.

My initial determination is to provide you a redacted list of investigations closed between January 1, 2014 and December 31, 2014. The titles of investigations are being withheld where necessary to protect the names of individuals and information that could identify the names of the protected individuals pursuant to FOIA exemption (b)(6), which protects from disclosure information that would constitute a clearly unwarranted invasion of personal privacy, and FOIA exemption (b)(7)(C), which relates to records compiled for law enforcement purposes that could reasonably be expected to constitute an unwarranted invasion of personal privacy. 5 U.S.C. 552 §§ 552(b)(6) & (b)(7)(C). In addition, two titles of investigations are also being withheld pursuant to FOIA exemption (b)(7)(A), which exempts from disclosure information compiled for law enforcement purposes, the disclosure of which could reasonably be expected to interfere with enforcement proceedings. Although these two cases are closed, there are closely related investigations that are open and active. I have determined that release of this information would be reasonably expected to interfere with those related, open investigations.

Fees associated with processing this request are under \$50.00 and therefore in accordance with 14 C.F.R. § 1206.503(c) are not being charged.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. See 5 U.S.C. § 552(c) (2006 & Supp. IV 2010). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.

You have the right to appeal this initial determination to the Deputy Inspector General. Under 14 C.F.R. §1206.700, the appeal must (1) be in writing; (2) be addressed to the Deputy Inspector General, NASA Headquarters, Washington, DC 20546; (3) be identified clearly on the envelope and in the letter as an "Appeal under the Freedom of Information Act"; (4) include a copy of the initial request for the Agency record and a copy of the adverse initial determination along with any other correspondence with the FOIA Office; (5) to the extent possible, state the reasons why the requester believes the adverse initial determination should be reversed; and (6) be sent to the Deputy Inspector General within 30 calendar days of the date of the initial determination.
