The Center for Competitive Politics ("CCP") hereby requests under the Freedom of Information Act ("FOIA"), 5 U.S.C. § 552, all documents relating to FEC Matters Under Review ("MURs") 4568, 4633, 4634, 4736, 4783 and 5294. CCP is able to and will obtain all public documents in the case of *Federal Election Commission vs. Carolyn Malenick, (TRIAD) et al.*; Civil Action No. 02-CV-01237, and do not request that the Commission reproduce those court-related documents that are publicly available. However, CCP does request a copy of all documents outlined below that were a part of the above-mentioned Court case, but were also the basis of MURs 4568, 4633, 4634, 4736, 4783, and 5294.

Please provide all documents related to the Commission's investigation, determination, and/or resource allocation for the above-mentioned MURs and court case, including:

- FEC email strands, both internal and external;
- FEC electronic records, internal and external;
- FEC inter- and intra-office correspondence, including post-it notes and hand written notes;
- FEC staff time sheets and/or allocations of time spent on these MURs and the related court case;
- FEC dollars spent on all MURs and court case;
- FEC accounting records of the costs and staff salaries associated with these MURs and related court case;
- FEC planning documents, including staff notes and/or charts or documents developed to organize and/or create any investigative, enforcement and/or litigation timeline(s) over the course of the MURs and court case, spanning from January 1996 through December 2006;
- FEC documents created, developed, used, or reviewed by the Commission in relation to the court case or MURs that are not in the public domain;
- FEC documents that show how the MURs and court case were characterized, summarized, or described to the Commissioners by the Office of General Counsel and/or Staff Director;

- FEC Commissioners' written opinions and vote counts at each phase of each MUR and the court case.


If any documents are determined to be exempt from production please list each such document and the specific exemption(s) on which the Commission relies in withholding each such document.

CCP requests, pursuant to 5 U.S.C. § 552(a)(4)(A)(iii), that all fees associated with this request be waived. As stated by the Commission, the alleged severity of these MURs and court case makes them particularly important for the public's understanding of campaign finance law and its enforcement. CCP also believes it is important and in the public interest to learn how the Commission used federal resources and proceeded in enforcing this case. Disclosure of the above-listed information is in the public interest because publication of such information is likely to contribute significantly to a public understanding of the operations and activities of the Federal Election Commission and of federal campaign finance law.

CCP is a non-profit 501(c)(3) organization. Its mission, through legal briefs, studies, comments, and analysis is to educate the public on the actual effects of money in politics, and the results of a more free and competitive electoral process.

If the Commission, nonetheless, determines that this request is not eligible for a waiver of fees, please provide me an estimate of costs of production. A member of CCP is available to appear at the FEC's office to review any and all information that has been listed for this FOIA request.



Pursuant to the Freedom of Information Act (FOIA), I hereby request the following:

***All documents related to "the several specific steps" that White House Chief of Staff Rahm Emanuel and White House Counsel to the President Bob Bauer instructed your agency to take in a 16 March 2010 memo to all agency and department heads. The memo is available at [http://www.whitehouse.gov/sites/default/files/rss\\_viewer/foia\\_memo\\_3-16-10.pdf](http://www.whitehouse.gov/sites/default/files/rss_viewer/foia_memo_3-16-10.pdf)***

***The "specific steps" that the memo instructed your office to implement include:***

- 1) "update[ing] all FOIA guidance and training materials to include the principles articulated in the President's memorandum" and***
- 2) "assess[ing] whether you are devoting adequate resources to responding to FOIA requests promptly and cooperatively."***

If you regard any of these documents as potentially exempt from the FOIA's disclosure requirements, I request that you nonetheless exercise your discretion to disclose them. As the FOIA requires, please release all reasonably segregable non exempt portions of documents. To permit me to reach an intelligent and informed decision whether or not to file an administrative appeal of any denied material, please describe any withheld records (or portions thereof) and explain the basis for your exemption claims.


