The Office of Government Ethics (OGE) is granting in part and denying in part your Freedom of Information Act (FOIA) request, which was received by the OGE FOIA Office on December 12, 2011. In your request, you asked for the following records:

- 1) An electronic copy of the records provided to the Honorable Chairman Darrell Issa, whose office in January 2011 asked [OGE] for various data concerning the administration of the FOIA.
- 2) A copy of any correspondence whatsoever sent by OGE to Chairman Issa's office on the subject of the January 2011 inquiry, and any correspondence sent by OGE during calendar year 2011 to Chairman Issa's office on the subject of the FOIA.

An electronic PDF copy of the records provided in response to Honorable Chairman Darrell Issa's January 2011 request is being sent to your email address subject to deletions under FOIA Exemption 6, 5 U.S.C. § 552(b)(6) as information the disclosure of which would constitute a clearly unwarranted invasion of personal privacy. The deletions are each marked with a reference "Exemption (b)(6)" in the enclosed copies.

We are enclosing two pages in full of correspondence sent by OGE to Chairman Issa's office on the subject of the January 2011 inquiry. These records are being provided to you without charge.

OGE has searched and has not located any other records responsive to your request for correspondence sent by OGE during calendar year 2011 to Chairman Issa's office on the subject of the FOIA. However, we are including links to OGE's FY 2012 Budget Submission to Congress, OGE's FY 2011 Performance Accountability Report (PAR), and the transmittal letter for OGE's FY 2011 PAR. Although these documents are not specifically on the subject of the FOIA, the reports briefly address OGE's administration of the FOIA program.

This is in response to your January 25, 2011, request for information regarding the Freedom of Information Act (FOIA) program at the U.S. Office of Government Ethics (OGE). Specifically, you requested the following information, records, and explanations.

1. Provide your agency's FOIA log(s) for the five years preceding the date of this letter, in Microsoft Excel or a similar format that allows sorting by column or information category, including at least the following information: (a) the name of the requester; (b) the date of the request; (c) a brief description of the documents or records sought by the request; (d) any tracking number assigned to the request by your agency pursuant to Section 7 of the OPEN Government Act of 2007; (e) the date the request was closed, if it is not still outstanding; (f) whether any records were provided in response to the request; and (g) any additional identification number or code assigned to the request by your agency for internal use.

OGE has placed its FOIA logs for Fiscal Years 2006 through 2011 on the enclosed flashdrive. These logs were created in a Microsoft Word format and contain the six categories of information that you requested. On January 31, 2011, I spoke with Tegan Millspaw of your staff and she indicated that the Microsoft Word format was acceptable.

As of February 15, 2011, OGE does not have any pending FOIA requests that were received more than 45 days prior to the date of your letter.
