## Re: Freedom of Information Act Request (OIG Tracking Numbers 15-015)

This is in response to your Freedom of Information Act (FOIA) request dated December 31, 2014, in which you requested a "listing of IG investigations closed during calendar year 2014." Your request was received in this office on December 30, 2014.

In response to your request, we have extracted from our database a list of closed investigations, which we are releasing to you with certain information withheld pursuant to Exemptions 3(A), 6, 7(A), 7(C) and 7(D) under the FOIA. Exemption 6 of the FOIA, 5 U.S.C. §522(b) (6), relates to personal information regarding persons other than yourself. Release of this information would constitute a clearly unwarranted invasion of the personal privacy of the persons mentioned in the records. Similarly, information withheld pursuant to Exemption 7(C) of the FOIA, 5 U.S.C. §522(b)(7)(C), relates to personal information regarding persons other than yourself that is compiled for law enforcement purposes. Release of this information could reasonably be expected to constitute an unwarranted invasion of the personal privacy of the persons mentioned in the records. Redactions marked Exemption 7(C) or Exemption (6) are also covered by the other exemption. Additionally, information withheld pursuant to Exemption 3(A) of the FOIA, 5 U.S.C. §552(b)(3)(A), is specifically exempted from disclosure by a statute that requires that the information be withheld from public disclosure, specifically, the qui tam provisions of 31 U.S.C. §§ 3729 and 3730. Exemption 7(D) of the FOIA, 5 U.S.C. §552(b)(7)(D), was applied because release of that information could have reasonably been expected to disclose the identity of a confidential source, including a State, local, or foreign agency or authority of any private institution which furnish information on a confidential basis. Finally, we are withholding certain matters pursuant to Exemption 7(A) of the FOIA, 5 U.S.C. §552(b)(7)(A). These cases generally have been converted to other cases which remain open, or they are related to other open cases. Release of information pertaining to those matters could reasonably be expected to interfere with ongoing enforcement proceedings.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirement of the FOIA. See 5 U.S.C. § 552(c) (2006 & Supp. IV (2010)). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not exist.

You have the right to appeal the adequacy of our search or for disclosure of any undisclosed information by writing to the Freedom of Information Act Office, Office of the Inspector General, General Services Administration, 1800 F Street, NW, Room 5332, Washington, D.C. 20405, within 120 days of your receipt of this letter. The appeal must be in writing and contain a statement of reason for the appeal. Please enclose copies of your initial request and this response. The envelope and letter should be clearly marked as a "Freedom of Information Act Appeal."
