Re: Freedom of Information Act (FOIA), 5 U.S.C. § 552 Request No. 15-00001-OIG

This letter is our final response to your request dated December 31, 2014, and received by the SEC Office of Inspector General on January 6, 2015, for a copy of the list or printout or database listing of IG investigations closed during calendar year 2014. Your request was forwarded to and received in this office for processing on January 9, 2015.

Access is granted, in part, to the enclosed 1-page document. Certain information is being withheld under 5 U.S.C. \$552(b)(3), (6) and/or (7)(C), 17 CFR \$200.80(b)(3), (6) and/or (7)(iii).

Information has been redacted from the enclosed document in accordance with the Inspector General Act of 1978 (Pub. L. 95-452), 5 U.S.C. App. § 7(b), which prohibits the SEC OIG from disclosing the identity of an employee, without the employee's consent, when that employee has filed a complaint with the SEC OIG. This information is therefore exempt from public disclosure under the provisions of FOIA Exemption 3.

Under Exemption 6, the release SEC staff names would constitute a clearly unwarranted invasion of personal privacy. Similarly, under Exemption 7(C) release of this information could reasonably be expected to constitute an unwarranted invasion of personal privacy. Further, public identification of SEC staff could conceivably subject them to harassment and annoyance in the conduct of their official duties and in their private lives.

I am the deciding official with regard to this adverse determination. You have the right to appeal my decision to our General Counsel under 5 U.S.C. § 552(a)(6), 17 CFR § 200.80(d)(5) and (6). Your appeal must be in writing, clearly marked "Freedom of Information Act Appeal," and should identify the records at issue. The appeal may include facts and authorities you consider appropriate.
