This is in response to your letter dated October 27, 2008, which was received by the Office of Inspector General (OIG) on November 07, 2008, in which you ask for information under the Freedom of Information Act (FOIA), 5 U.S.C. § 552. You ask for a copy of a printout from OIG database of all OIG Investigations closed during the time period January 1, 2007 to present. You state that we could use a starting date of October 1, 2006 if this would be easier. You also ask that this printout should include as many fields as possible, particularly the fields that describe the subject or topic type of each investigation and the case number assigned to the investigation.

Enclosed is a nine page listing of investigations closed between October 1, 2006 through October 27, 2008. The OIG closed four-hundred and fourteen investigations. Deletions have been made of information that is exempt from release under the provisions of 5 U.S.C. §§ 552(b)(6) and (b)(7)(C). These sections exempt from disclosure items that pertain to: (1) personnel and other similar files the disclosure of which would constitute a clearly unwarranted invasion of personal privacy and (2) records of information compiled for law enforcement purposes, but only to the extent that the production of such law enforcement records or information could reasonably be expected to constitute an unwarranted invasion of personal privacy. Exemptions (b)(6) and (b)(7)(C) were used to protect the personal privacy interests of those individuals who are named as the subject in the report of investigation and the case number for the subject of the report. In addition, the material is exempt from release under the provisions of 5 U.S.C. § 552a(k)(2)of the Privacy Act, pertaining to investigatory material compiled for law enforcement purposes.

If you disagree with this response, you may appeal the decision by writing to the FOIA Appeals Officer. The FOIA Appeals Officer must receive your FOIA appeal no later than 30 workdays from the date of this final letter responding to your FOIA request. Appeals arriving or delivered after 5 p.m. F.I. Monday through Friday, will be deemed received on the next workday. Your appeal must be in writing and addressed to:

You must include with your appeal copies of all correspondence between you and the bureau concerning your FOIA request, including a copy of your original FOIA request and this denial letter. Failure to include this documentation with your appeal will result in the Department's rejection of your appeal. The appeal should be marked both on the envelope and the face of the letter, with the legend, "FREEDOM OF INFORMATION APPEAL." Your letter should include as much detail as possible any reason(s) why you believe the bureau's response is in error. Due to disruptions to the mail service in the Washington, D.C. area, you may want to consider an alternative means of communicating with the Department of the Interior, e.g., facsimile, e-mail. Federal Express, etc. There may be a delay in our receipt of mail sent through the U.S. Postal Service. The FOIA Appeal Officer's facsimile number is (202) 208-6677. Your appeal should be filed in accordance with the regulations set out in 43 C.F.R. §§ 2.28-2.32, a copy of which is enclosed.
