


Enclosed is a copy of the most recent annual resident hire report, "Nonresidents Working in Alaska-2005" as required by AS 36.10.130. The report describes the status of resident hire in Alaska by industry, occupation and geographic area.

The report shows that the number and percentage of nonresidents working in Alaska in 2005 increased due to strong growth in the construction, accommodations and food services, and mining (oil and gas) industries. The nonresident hire rate rose from 18.4 percent in 2004 to 19.1 percent in 2005. The total number of nonresident workers grew by nearly 3,900 from 2004, while the number of resident wage and salary workers grew by about 2,300.

Maximizing resident hire continues to be a high priority of the Alaska Department of Labor and Workforce Development. Industries and occupations with a high percentage of nonresident workers have been given high priority for new training dollars. Other efforts designed to increase resident hire include industry education and regulatory enforcement.

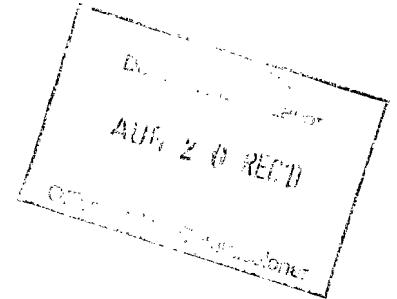

Dear Commissioner Bishop:

I am pleased to invite you to join the United States Mint, the Alaska Commemorative Coin Commission, and me for the official release of the Alaska commemorative quarter-dollar coin on Friday, August 29, 2008 at the Alaska State Fair Colony Stage in Palmer, Alaska. This historic event will begin at 1:00 p.m. and will last approximately one hour.

On January 3, 1959, Alaska became the 49th state in the Union, making this the 49th coin to be issued in the U. S. Mint's popular 50 State Quarters Program. The coin depicts a grizzly bear emerging from the waters clutching a salmon in its jaw. It also features the North Star above the inscription "The Great Land," along with "Alaska 1959."

The Alaska Commemorative Coin Commission worked diligently to put forth a design that does justice to the courage and strength of life on the last frontier. From the hundreds of designs submitted, four were selected for consideration by the United States Mint. After considering thousands of comments from around the state, I announced the final selection of the grizzly bear and salmon design on April 26, 2007. The Department of the Treasury approved the design on May 25, 2007, and we are now prepared to unveil the Alaska commemorative quarter.

The United States Mint Deputy Director Andrew Brunhart is scheduled to speak along with a Coin Commission designee and other dignitaries. The ceremony will be followed by a coin exchange, at which attendees may purchase \$10.00 rolls of Alaska quarter-dollars. We anticipate thousands to attend this historic event as part of the Alaska State Fair and I hope you will join us.

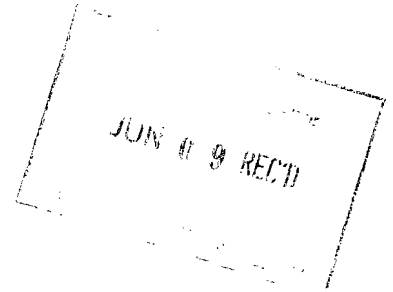

SUBJECT: Emergency Search and Rescue Operations

As we are all aware, successful search and rescue (SAR) operations are essential to the well-being of Alaska's citizens and visitors. There are many employees in our workforce whose state duties do not require SAR work but who have special skills and expertise to significantly contribute to the success of a SAR operation.

If there is a need to utilize state employees with special skills for SAR operations, they will be allowed the opportunity to volunteer. Their service will be strictly voluntary; they cannot be directed to participate. The commissioner of Public Safety or his designee is authorized to request volunteers from other departments. In most instances, the request will be for volunteers with special experience or training.

When the commissioner of Public Safety or his designee makes such a request, employees who volunteer and are accepted will be temporarily assigned to the Department of Public Safety for the duration of the need for their services. Accepted volunteers will not be placed on administrative leave, leave without pay, or be required to take annual leave. Although temporarily assigned to Public Safety, accepted volunteers will be carried as if in work status in their regular work assignment.

In order to facilitate emergency situations, the commissioner or designee may only contact an accepted volunteer's immediate supervisor. The supervisor will be responsible for making appropriate arrangements and notifying the employee of the temporary assignment. In many instances, employees are members of organized volunteer SAR organizations and have already established arrangements with their supervisors for emergency call outs.

Mike,

As soon as we heard about the fire that destroyed the Trident Seafoods fish processing plant in Chignik Bay on Monday, our Rapid Response Team contacted Trident's Chief Legal Officer Joe Plesha in Trident's Seattle corporate office.

Mr. Plesha declined our services, which he was advised include information on unemployment insurance, employment services, and possible training benefits for displaced workers. He stated that he appreciated the offer and will contact DOLWD if needed in the future.

About 250 workers were affected by the fire, which is still burning at a lesser rate at this time. The fire marshal is allowing small, escorted groups to go into their bunkhouses and retrieve the personal effects not destroyed by the fire.

Mr. Plesha said that 60 workers were flown out of Chignik Bay yesterday, and about 40 to 50 more will be flown out within the next two to three days. Most of the workers were from California. All travel expenses are being paid by Trident Seafoods, and the replacement value of some portion of the worker's personal effects will also be covered.

Only a small number of workers are Alaska residents.

Trident seems to be making every effort to mitigate the negative impact on its displaced workers. We've been told that every single employee displaced by the fire has been offered employment at other Trident processing plants around the state. Trident has plants in Akutan, Cordova, Petersburg, Sand Point, Ketchikan and Kodiak.

About 15 workers have already been placed on the fishing vessel Aleutian Falcon, scheduled to come into port in the next few hours. Another 15 workers will remain in Chignik Bay to help with the clean up and general maintenance of the remaining buildings like the bunkhouses; after that, they will have the option of being placed at one of the other plants.

Mr. Plesha said that the season will be wrapping up soon, and that the workers understand the seasonal nature of the business. They can choose to continue the season at other plants. One group of workers, the machinists, normally works year-round and can retain employment at the other plants.
