Dear Mr. Issa:

I am writing in response to your letter dated January 25, 2011 to the Committee for Purchase From People Who Are Blind or Severely Disabled (Committee) which requests records pursuant to the Freedom of Information Act (FOIA) 5 U.S.C. § 552. Your written request asks for copies of our agency FOIA Logs for the five-year period from FY 2006 to FY 2010, and four numbered requests for information related to actions identified herein.

I have decided to grant your request in full. The responsive documents are saved in the electronic format for Microsoft Office Excel 2003 spreadsheets, as requested. Please find separate files for each Fiscal Year requested as an eMail attachment sent to the attention of your staff.

The Committee's FOIA Logs are used primarily to track receipt of a request, and as a quick reference for the general public. The fields in a particular log without data may not be an indication that an actual value is not available. The detail of an action is available within the Committee's official record.

Request No. 2 and 3 relate to pending or in-process requests which fall outside the statutory guideline for a response, specifically submissions more than 45 days prior to your request or before December 10, 2010. The Committee has issued a complete and final response to all actions identified in these log files. No requests submitted on or before December 10, 2010 are outstanding.

Request No. 4 and 5 focus on Section 552(a)(4)(E) of Title 5 which makes plaintiffs who have "substantially prevailed" in FOIA litigation eligible for a recovery of reasonable attorney's fees. There are no FOIA litigations in this time frame nor is there any a cost or fees related to FOIA litigation involving the Committee.
