This email is in response to your Freedom of Information Act, 5 U.S.C. § 552 (FOIA), request to the Farm Credit Administration (FCA or Agency) dated December 10, 2011. You requested an electronic copy of FCA's response package for the Honorable Chairman Darrell Issa's January 2011 inquiry on FOIA administration. You also asked for any correspondence FCA sent to his office regarding this particular request as well as any FOIA related correspondence FCA sent to his office during calendar year 2011.

With respect to the first part of your request, the attached Excel file "FCA 5 Year FOIA log.xlsx" is fully responsive and I am releasing it in its entirety.

With respect to copies of certain correspondence sent from FCA to Chairman Issa's office, after a thorough search of the agency, we located 13 pages of responsive records. These pages are fully responsive and I am releasing them in their entirety.

Dear Mr. Chairman:

Thank you for your January 25, 2011, letter requesting the Farm Credit Administration's (FCA) Freedom of Information Act (FOIA) log for the 5 years preceding the date of your letter in sortable format containing certain information.

Prior to Calendar year 2011, the FCA's official FOIA log was maintained as a hard copy journal with handwritten entries. Starting in calendar year 2011, we started using an electronic log. To comply with your request, I am happy to report that we were able to create an Excel worksheet containing all the requested data in a format that allows for sorting by column or information category.

Attached to this letter is a hard copy printout of the FOIA log in Excel format that we created for this request, as well as a compact disc containing the electronic version thereof.

Please note that some of these FOIA requests were closed more than 20 business days from the date that we received the request, and that some of the requests do not have tracking numbers. It is our view and belief, however, that the FCA has fully complied with all FOIA and related requirements in processing all of these requests. For instance, where some of our responses appear to have been made more than 20 business days from the date we received the requests, there were one or more requests that were voluminous and required interim responses within 20 business days followed by rolling disclosures thereafter. For such requests, we did not log it as closed until all the rolling disclosures were complete. Furthermore, there were a number of days in which the government was closed due to inclement weather or holidays.

With respect to the tracking number requirement, only requests that were either received prior to January 1, 2009 (effective date of tracking number requirement) or responded to within 10 business days were not assigned tracking numbers.

I will be happy to provide you with supplemental information on particular FOIAs if necessary.
