Dear Chairman Issa:

I am writing in response to your request for information regarding the Freedom of Information Act (FOIA) program of the Inter-American Foundation (IAF). Consistent with the FOIA as well as President Obama's Executive Order regarding FOIA, the IAF places the highest priority on promoting open government and strives to provide citizen-centered access to government information.

With respect to the specific components of your request, I am glad to provide the following responses, information and/or records:

- Please find attached a copy of the IAF's FOIA log for the current Fiscal Year as well as the five preceding Fiscal Years, which provides the information you requested for the relevant timeframe. Please note that, due to the very small number of FOIA requests received annually by the IAF, requests are generally referenced and tracked by requestor's last name rather than a tracking number. In case of multiple requests from a requestor, or requestors, with the same last name, requests are referenced or tracked by the requestor's last name paired with a number assigned based on the order in which the request was received.
- 2. Currently, the IAF has no pending FOIA requests that were submitted more than 45 days prior to January 25, 2011 and to which the IAF has not yet issued a complete and final response.
- 3. In light of the IAF's response to Request No. 2, Request No. 3 is not applicable.
- 4. Currently, there is no federal judicial action in which the IAF, within five years preceding January 25, 2011, has been ordered by the court to pay any attorneys' fess or other litigation costs incurred by a FOIA requestor under 5 U.S.C. § 552(a)(4)(E) or under any similar law or regulation.
- 5. In light of the IAF's response to Request No. 4, Request No. 5 is not applicable.
