This is in response to your letter dated January 25, 2011. Specifically, you requested the following information. Our response to your request is in bold.

1. 





Peace Corps does not classify any positions as Schedule C or Senior Executive Service. We are providing you with the resumes of employees who are in analogous positions.

The Peace Corps does not maintain information on candidates not selected for a position. Additionally, the identities of persons who apply but are not selected for federal government employment may be protected pursuant to FOIA Exemption 6, 5 U.S.C. § 552(b)(6), because the individuals' right to privacy outweighs the general public's interest in seeing personal information. The Peace Corps only maintains personnel records of current employees or separated employees for 90 days after service. We located 96 pages of responsive documents. After careful review, 38 pages were redacted pursuant to FOIA Exemption 6. Federal employees' home addresses, telephone numbers, social security numbers and other personal information are exempt from disclosure.
