Records regarding Apple iPads et al.

This is in response to your request dated August 17, 2011, under the Freedom of Information Act seeking access to documents regarding the benefits or disadvantages of using Apple iPads or other tablets for employee use. In accordance with the FOIA and agency policy, we have searched our records, as of August 24, 2011, the date we received your request in our FOIA office.

We have located eight pages of responsive records, I am granting partial access to and am enclosing copies of, the accessible records. Portions of these pages fall within one of the exemptions to the FOIA's disclosure requirements, as explained below.

Some responsive records contain staff analyses, opinions, and recommendations. Those portions are deliberative and pre-decisional and are an integral part of the agency's decision making process. They are exempt from the FOIA's disclosure requirements by FOIA Exemption 5.5 U.S.C. § 552(b)(5); see NLRB v. Sears, Roebuck & Co., 421 U.S. 132 (1975).

If you are not satisfied with this response to your request, you may appeal by writing to Freedom of Information Act Appeal, Office of the General Counsel, Federal Trade Commission, 600 Pennsylvania Avenue, N.W., Washington D.C. 20580, within 30 days of the date of this letter. Please enclose a copy of your original request and a copy of this response. If you believe that we should choose to disclose additional materials beyond what the FOIA requires, please explain why this would be in the public interest.

Thank you for the call. Here are some of the features and how it will work with the BlackBerry.

BB Bridge:

This is the profile that is on the PlayBook that will allow the PlayBook to connect on to the BlackBerry.

It is AES 256 bit encrypted Bluetooth tunnel to secure the data going back and forth.

This will display email, calendar, contacts, tasks, BBM on the PlayBook.

It will also be how you push IT policies for the PlayBook from the BES through the BlackBerry to the

PlayBook.

When the Bluetooth connections is cut, the information on the PlayBook disappears.

NEEDS: The BlackBerry needs to be on OS 5.0 or higher, preferably at BB6.

BB Balance:

This is a feature that will be available on the BES to separate out personal/enterprise information. You will be able to sandbox off the enterprise data so that you can allow the PlayBook user to have personal information and applications without compromising your FTC network.

You are able to pre-order the PlayBooks through retailers like Best Buy and Staples but also through government resellers like CDWg. RIM will also be taking pre-orders directly from our clients. I can send out the access code when we get them. Please let me know if you do pre-order any PlayBooks.
