This is in response to your letter dated August 1, 2007, which was received by the Office of Inspector General (OIG) on the same date, in which you ask for information under the Freedom of Information Act (FOIA), 5 U.S.C. § 552. You ask an electronic copy of the FOIA case logs from FY 2006 and FY 2007.

A search was conducted and three documents were determined to be responsive to your request. The three documents total 23 pages. All 23 pages contain some information that is being withheld.

Deletions have been made of information that is exempt from release under the provisions of 5 U.S.C. §§ 552(b)(6) and (b)(7)(C). These sections exempt from disclosure items that pertain to: (1) personnel and other similar files the disclosure of which would constitute a clearly unwarranted invasion of personal privacy and (2) records of information compiled for law enforcement purposes, but only to the extent that the production of such law enforcement records or information could reasonably be expected to constitute an unwarranted invasion of personal privacy. Exemptions (b)(6) and (b)(7)(C) were used to protect the personal privacy interests of an individual who made a FOIA/Privacy Act request who is the subject of a report of investigation, interviewees, and witnesses named in the investigative file. Under the Privacy Act, 5 U.S.C. § 552a, OIG may not disclose information contained in a system of records without the prior written consent of the individual to whom the record pertains.
