Re: Sunshine Law Request

In your letter dated October 27, 2012 and received by this office October 30, 2012, you request a copy of the list of prohibited personalized license plates, the internal instructions to DMV employee regarding screening personalized license plate applications and each administrative appeal letter regarding the Department's decision regarding personalized license plates. Your letter has been referred to me for response.

Department personnel are in the process of reviewing Department records to determine the existence of records responsive to your request, and to determine whether any such records are subject to disclosure under Missouri Sunshine Law provisions. *See* Section 610.021, RSMo. Upon conclusion of that process, which should be completed within approximately the next 7 to 10 business days, I will advise you of the records that are accessible and the costs for providing access to such records. Any such costs would need to be paid in advance and prior to the disclosure of any open and responsive records.
