This is in response to your Freedom of Information Act (FOIA), 5 U.S.C. § 552, request dated February 9, 2013, to the U.S. Department of State's Office of Inspector General (OIG).

You requested "a printout/list/digital file of the OIG investigations closed during calendar year 2012." You further requested that the document "include the subject, title and topic of the closed investigation, and whatever other fields are available such as the date opened and the date closed, the case number, etc."

OIG conducted a search and located one document responsive your request. The document is being released to you in part, redacted under FOIA exemptions (b)(6) and (b)(7)(C). We have enclosed a separate sheet explaining the exemptions.

Please note that the FOIA does not require agencies to create documents in response to an individual's request for information.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. *See* 5 U.S.C. § 552(c) (2006 & Supp. IV 2010). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.

You may appeal this decision within 60 days to the Chairman of the Appeals Panel of the U.S. Department of State as explained in the enclosed. Appeals should be addressed to: Chairman, Appeals Review Panel, Attention: Appeals Officer,
