As Disclosure Officer for the Bureau of Labor Statistics (BLS), I am responding to your October 8 Freedom of Information Act (FOIA) request for an electronic copy of the FOIA case logs maintained by the BLS (to the extent available) for the time period of FY 2005, FY 2006, and FY 2007 to-date.

I am enclosing a copy of the BLS FOIA logs covering FY 2005, FY 2006, and FY 2007.
