This responds to your request dated August 13, 2007 to the Department of Justice (DOJ), Interpol-U.S. National Central Bureau (USNCB) pursuant to the Freedom of Information Act/Privacy Act (FOIA/PA) for a copy of the FOIA Case Logs for the period FY 2005, FY2006, and FY2007 to date. We received your request on August 27, 2007. Please refer to the above FOIA number assigned to your request in any additional correspondence.

We have located forty-four (44) records responsive to your request. We are releasing forty-one (41) records with partial deletions pursuant to Title 5, United States Code, § 552 (b)(6) and (b)(7)(C) of the FOIA. The other three records have partial deletions pursuant to Title 5, United States Code, § 552 (b)(2), (b)(6) and (b)(7)(C) of the FOIA. Exemption (b)(2) applies to material related solely to the internal personnel rules and practices of an agency. Exemption (b)(6) of the FOIA exempts from disclosure personnel, medical or similar records which would constitute a clearly unwarranted invasion of personal privacy. Exemption (b)(7)(C) of the FOIA relates to records or information compiled for law enforcement purposes only to the extent that the production of such law enforcement records or information, if disclosed, could reasonably be expected to constitute an invasion of personal privacy.

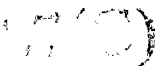
