This responds to your April 13, 2004 Freedom of Information Act (FOIA) request addressed to the Criminal Division seeking access to "terrorism-related DOJ Criminal Division indictments since January 1, 1994." Your request was forwarded to this office on February 29, 2008. The Criminal Division made this referral to the National Security Division (NSD) because any records arguably responsive to your request are currently maintained by the NSD. The NSD was created in October 2006 by consolidating two former Criminal Division sections (Counterterrorism and Counterespionage) with the Office of Intelligence Policy and Review.

Please note, the Counterterrorism Section within the NSD does not indict cases. Only the US Attorneys offices perform this function. However, in response to your request, the Counterterrorism Section has generated an internal report that identifies the defendant, district, charging date and applicable charging statute for some terrorism-related cases. Since the NSD is not the official repository for any indictments, you must contact the following office if you require any additional information:
