This letter responds to your recent Freedom of Information Act (FOIA) request received by the Federal Communications Commission (FCC or Commission) and assigned to the Consumer & Governmental Affairs (CGB) and Enforcement (EB) Bureaus. Your request seeks copies of complaints received at the FCC regarding the television show "Two and a Half Men."

CGB and EB conducted a search of the databases containing informal complaints. According to the Commission's Records Control Schedule for Informal Complaints ("Records Control Schedule"), the Commission is not required to maintain informal complaints and related correspondence for more than three years after the case is closed. *See N1-173-07-1, FCC Disposition Authority.* Therefore, all complaint records prior to January 1, 2010, have been purged pursuant to the Records Control Schedule. CGB identified ninety-eight complaints responsive to your request. Copies of the responsive documents are enclosed. EB found no additional responsive documents.

All personal identifying information relating to the individuals who submitted or are named in the enclosed complaints or inquiries has been redacted based on Exemption 6 of FOIA, which permits agencies not to disclose files that would clearly invade personal privacy.¹ Some FCC employee names have also been redacted based on Exemption 2 of FOIA, which permits agencies not to disclose internal personnel rules and practices.²

Please be advised that the Commission receives many complaints and comments that do not involve violations of the Communications Act or any FCC rule or order. Thus, the existence of a complaint filed against a particular carrier or business entity does not necessarily indicate any wrongdoing by any individuals or business entities named in the complaint.

FOIA and FCC rules require the FCC to charge requesters for time spent searching for and reviewing responsive documents, and for copying them.³ Based on your classification as an "all other" requester, the FCC does not charge you for the first two hours of search time and the first 100 pages of copying.⁴ Because preparing the response to your request falls within these limits, the FCC is not charging you for processing it.

If you think this response denies your FOIA request, you may file an application for review of this decision with the FCC's Office of the General Counsel within 30 days.⁵ Both the application and envelope containing it must be marked "Review of Freedom of Information Action" and the application should refer to FOIA Control No. 2014-049.

Im confused why programs like two and a half men cannot air on tv until a certain hour, yet the re-runs can start at 5pm... Fortunately the parental controls prevent them viewing this material.

To Whom It May Concern:

I am a member of the Parents Television Council. I am writing regarding the September 20 episode of ?Two and a Half Men? on WHIO 7, Dayton's CBS affiliate. I found this episode extremely offensive for graphic sexual content, including the promotion of pornography, implied teenage orgies, and kinky sex. I am not concerned about the nature of your commercial; rather, I am complaining about the fact that by sponsoring such a filthy program, you are supporting it.

Here is a description of the show, courtesy of the Council, to let you know exactly what the station aired:

-----BEGIN DOCUMENTATION------

The plot of the odious season opener finds teenager Jake confronted by his father Alan, who has seen two girls sneaking away from the house. Alan prepares to storm into Jake's room and get to the bottom of the situation. Since this is Two and a Half Men, Alan does not suspect Jake of visiting with the girls, or even kissing them. No, the first assumption of this show's sex-crazed parental character is...

Alan: "The possibility of my son hosting an orgy."

Charlie: "Now, not to be a stickler, but technically an orgy requires a minimum of six participants. It goes: masturbation, one on one, threesome, two couples swinging, two couples swinging with a lookie-loo, orgy 6."

Alan: "It frightens me that you know that."

Charlie: "Everybody knows that."

Alan: "Whatever you call it, it needs to be nipped in the bud."

Alan: "Really? You're going to preach sexual restraint to me?"

Charlie: "Let me explain something to you, Alan, Jake expects me to betray his trust. You, on the other hand, are held to a higher standard... you're like a right wing family values senator caught on his knees in an airport toilet with a male hooker."

And the sleaze never stops, with further remarks about Alan's current hookup having made a pornographic movie (explicitly described by Alan's friend Herb), and a scene at the end involving Charlie watching the movie in question. Pornography, implied teenage orgies, kinky sex...CBS has it all, on at 8:00 p.m. Central/Mountain...and [producer] Chuck Lorre couldn't be prouder.

If that is not shocking enough, check out Mr. Lorre?s ?proclamation? in the closing credits in which he ridicules the idea of the networks maintaining any decency standards whatsoever:

-----BEGIN DOCUMENTATION-----



HONEYCUT: ?Well, how ?bout we forget the money and I?ll show you something I learned in Guadalajara.?



Alan: "Good lord, quite the gymnast." Charlie: "I know. I never understood why this isn't in the Olympics but synchronized diving is."

Charlie holds a bill out to the dancer and asks, "Hey honey, when does Miss Bush come out?"

Stripper: "Whenever Mr. Franklin comes out." Alan; "I mean Desiree Bush."

Charlie pays for Alan to receive a lap dance from Miss Pasternak so that he can talk to her. She is shown graphically gyrating on his lap, and Alan makes comments indicating that he is aroused. Charlie tells Miss Pasternak that he wants to help her get on her feet, Alan says: "Not yet! Not yet!" When she lays her stomach on his lap and wiggles around he moans: "Oh, doggies!"

She puts her knee between his thighs and slaps her own buttock while she gyrates.

Alan: "Excuse me, excuse me, I've got to readjust. I'm playing ring toss with my car keys,"

She gets up and starts talking with Charlie.

Alan: "Ok, ok I'm all set. We can continue." Charlie: "Alan, this doesn't concern you." Alan: "At this time, it kind of does. Come on, hop on pop." She gets on his lap, straddles him, and her breasts are in his face. Alan: "Thank you!" (moaning in his voice) Charlie then discusses hiring Miss Pasternak to be a private tutor for Jake.
