This letter is the Office of Inspector General's (OIG's) response to the above-identified Freedom of Information Act (FOIA) request, dated May 25, 2014. In your request you asked for "the list of investigations closed during calendar year 2013."

The included spreadsheet is a printout from our Case Management System (CMS). Please note that the CMS is not a perfect snapshot of the OIG caseload. Because of the technical vagaries of the system, cases may effectively be closed prior to their being noted as such in CMS. Thus, the attached document does not include several cases that were closed in 2013 because they were uploaded into CMS after that date. Similarly, there is a lag time between when a case is opened and when it is entered into CMS, and consequently the printout also includes cases that appear to have been closed in 2013, but may have actually closed in the prior year.

In addition, the names of individuals subject to investigation, as well as the names of the investigators have been redacted pursuant to FOIA exemptions 6 and or 7. 5 U.S.C. § 552(b)(6),(7).

If you believe that this letter constitutes a denial of your request, you may file an application for review with the FCC's Office of General Counsel within 30 calendar days of the date of this letter in accordance with section 0.461(j) of the Commission's rules, 47 C.F.R. § 0.461(j).
