This is the final response to your 16 Nov 09, Freedom of Information Act (FOIA) request, amended on 3 Dec 09, for the most recent fiscal year reports produced for Congress by the Office of the Secretary of Defense (OSD).

We tasked OSD Legislative Affairs with your request. That office advised that not all Reports to Congress are prepared as required under a particular year National Defense Authorization Act (NDAA) requirement; and, that components sent most of their reports to the Hill in hardcopy, and a relatively small percentage of those reports are on CHARRTS. We forwarded to you on 14 Aug 13, a listing of reports from the Congressional Hearings and Reporting Requirements Tracking System (CHARRTS). OSD LA also tells us that OSD does not keep a website holding only completed reports that is easily accessible and downloadable; that the Congress has put forward this idea but it has never been instituted.

However, OSD LA staff, sent to us the attached tracker and advised that it does not track all reports. Similar to our previous response sending you CHARRTS, the spreadsheet only provides the listing of some of the DoD reports. If there are any reports listed of interest, please submit a new request, and be as specific as you can about the report desired in order that we can coordinate with Legislative Affairs to find it or steer us to the component that was responsible for its preparation. And, if you can determine that a report may have originated or was prepared by the Army, Navy, etc., please direct your request to the respective FOIA office.

If you are not satisfied with this action, you may appeal to the appellate authority, the Director of Administration and Management, Office of the Secretary of Defense, by writing directly to the Defense Freedom of Information Policy Office, Attn: Mr. James Hogan, 1155 Defense Pentagon, Washington, D.C. 20301-1155. Your appeal should be postmarked within 60 calendar days of the date of this response, should cite to case number 10-F-0310, and should be clearly marked "Freedom of Information Act Appeal."
