This letter is in response to your FOIA request dated June11, 2015 and received by the Bureau of Ocean Energy Management (BOEM) on the same date. Your request has been assigned request number BOEM-2015-00145. Please refer to this number in any future correspondence with our office regarding this request.

## Description of the Requested Records

You requested, "an electronic copy of the BOEM FOIA Case Log for FY2012, FY2013, FY2014 and FY2015 to date."

## Final Response

We ran the "Bureau FOIA Log Report" in the Department of the Interior's (DOI's) electronic FOIA tracking system (EFTS) on June 18, 2015. Reports were run for fiscal years 2012, 2013, 2014 and 2015 (to the date of the search). Our search resulted in the retrieval of the attached four FOIA logs (33 pages total) that are responsive to your request. We are releasing them to you in full in the format in which they were generated in the EFTS. Please note that fields in the logs marked, "Exempt," contain information that has been deleted because it is covered by FOIA Exemption 6. Exemption 6 protects "personnel and medical files and similar files the disclosure of which would constitute a clearly unwarranted invasion of personal privacy." 5 USC § 552(b)(6). However, since we are releasing the logs as they exist in our records, we consider this response to be a full grant of your request.

### Fees

We do not bill FOIA requesters for processing fees when their fees are less than 50.00, because the cost of collecting the fee would be greater than the fee itself. See 43 CFR § 2.49(a)(1). Therefore, there is no billable fee for the processing of this request.
