The U.S. Office of Government Ethics (OGE) is granting your Freedom of Information Act (FOIA) request, which was received by the OGE FOIA Office on July 23, 2015. This request was assigned tracking number OGE FOIA FY 15/52. In your request, you asked for a listing of educational and other products available in the Institute for Ethics in Government (IEG) MAX Community, such as educational course materials, practical job aids, and reference guides. The request stated that printouts from the IEG MAX website will suffice. Accordingly, we are enclosing five pages from the IEG MAX website listing all IEG store community products and OGE products. The OGE official responsible for this FOIA determination is the undersigned. If you consider this response to be a denial of your request, you may administratively appeal this determination in accordance with the FOIA, as codified at 5 U.S.C. § 552(a)(6)(A), and OGE's FOIA regulations, at 5 C.F.R. § 2604.304, to the General Counsel, U.S. Office of Government Ethics, 1201 New York Avenue, N.W., Suite 500, Washington, DC 20005-3917. Any such appeal must be in writing and must be sent within 30 days of the date you receive this response letter. If you do appeal, you should include copies of your request and this response, together with a statement of why you believe this initial determination is in error. Also, if you appeal, you should clearly indicate on the envelope and in the letter that it is a "Freedom of Information Act Appeal."
