A few things to note...all logs except for the Bush Library were generated using preexisting report functions without requester privacy information. The privacy information has been withheld in the Bush Library log under (b)(6). Also, the NARA log represents requests received for operational records. We have no approved method for electronically extracting information from the classified ADRRES system, so we cannot provide the archival FOIA log in that format.
