Enclosed are records responsive to your request. Personal information was redacted from these case logs. The deleted material is exempt from disclosure under 14 C.F.R. 1206.300(b)(6) which permits the Government to withhold all information about individuals in "personnel and medical files and similar files" when the disclosure of such information "would constitute a clearly unwarranted invasion of personal privacy."

Since information is being withheld, you have a right to appeal to the NASA Administrator if you are dissatisfied with this response. The appeal must (1) be addressed to the Administrator, NASA, Washington, D.C. 20546; (2) be identified clearly on the envelope and in the letter as an "Appeal under the Freedom of Information Act;" (3) include a copy of the request for the agency record and a copy of this initial determination; (4) to the extent possible, state the reasons why you believe this determination should be reversed; and (5) be sent to the Administrator within 30 calendar days of the date of receipt of this initial determination.

This information is furnished under the provisions of the FOIA. Due to the extensive amount of time it has taken to process this request, all fees have been waived.
