This responds to your Freedom of Information Act (FOIA) 5 U.S.C. § 552, request to the National Indian Gaming Commission (NIGC) received in the FOIA office on March 9, 2016. You requested:

- “A digital/electronic copy of the NIGC database that logs requests from tribal gaming operators and regulators for IGRA and gaming related training and technical assistance.”

The NIGC FOIA Office has conducted a search of its files and has located 1 document (totaling 5 pages) responsive to your request that is being released to you in full.

Please note that for fee purposes you were designated an “**all others**” requester. This designation entitles you to no charge for the first 2 hours of search time, no charge for review time; and, no charge for the first 100 pages of duplication. 25 C.F.R. § 517.9(d)(2). The duplication for this request did not exceed that threshold. Accordingly, you are not required to pay any fees with respect to this request.
