This is the final response to your Freedom of Information Act (FOIA) request to the Department of Homeland Security (DHS)/Federal Emergency Management Agency (FEMA), dated February 21, 2016 and received by this office on February 22, 2016. You requested a copy of a list of the number of facilities in the National Shelter System (NSS) database by state.

We conducted a comprehensive search of FEMA's Office of Response and Recovery Directorate for documents responsive to your request. The search produced one (1) page. After carefully reviewing the responsive document pursuant to the FOIA, 5 U.S.C. § 552, we have determined the document is appropriate for release. It is enclosed in its entirety; no deletions or exemptions have been claimed.

You have a right to appeal the above withholding determination. Should you wish to do so, you must send your appeal and a copy of this letter, within 60 days of the date of this letter to the subsequent address: Office of the Chief Administrative Officer (OCAO)/Records Management Division (FOIA Appeals), FEMA, 500 C Street SW, Seventh Floor, Mail Stop 3172, Washington, DC 20472-3172, following the procedures outlined in the DHS regulations at 6 C.F.R. § 5.9. Your envelope and letter should be marked "FOIA Appeal." Copies of the FOIA and DHS regulations are available at www.dhs.gov/foia.

Provisions of the FOIA allow us to recover part of the cost of complying with your request. In this instance, because the cost is below the \$14 minimum, there is no charge. 6 C.F.R. §5.11(d)(4).
