# The United States Secret Service

The United States Secret Service is a Division of the Treasury Department, and is one of the oldest and best-known law-enforcement agencies of the Federal Government. It was established during the time of the Civil War, and celebrated its seventy-ninth anniversary on July 2, 1943.

## \* \* \* \*

Among others, the chief duties of the Secret Service are: Protection of the person of the President of the United States, his immediate family, and the person elected to be President; Policing of the White House and its ground by the White House Uniformed Force, a unit of the Secret Service.

### \* \* \* \* \*

Protection of visiting members of Royal Families, Presidents, Prime Ministers, and Heads of Foreign Governments, and other Foreign Dignitaries upon their visits to this country. This protection is usually maintained as long as they are within the Continental United States.

### \* \* \* \* \*

Suppression of the counterfeiting and alteration of all paper money, coins, bonds, stamps, and other obligations of the United States and foreign governments.

#### \* \* \* \* \*

Suppression of the counterfeiting, forgery, alteration, and fraudulent negotiation of United States Treasury Checks, and enforcement of other laws relating to the Treasury Department, as provided by the Congress of the United States.

## \* \* \* \* \*

Protection of the Treasury Building, the Bureau of Engraving and Printing, other Treasury Buildings, and safeguarding of monies and securities. This is accomplished by the Uniformed Force of the Secret Service.
