This is in response to your Freedom of Information Act request dated October 28, 2016 and received in our office on November 2, 2016, via U.S. mail. Your request was assigned FOIAonline tracking number NARA-NGC-2017-000071, and the internal tracking number listed above. In your initial request you sought access to the following: Mandatory Declassification Review (MDR) LOG maintained by the National Archives and Records Administration. I am primarily interested in the time period 2010 to present.

We have identified three spreadsheets containing information responsive to your FOIA request. All three Mandatory Declassification Review (MDR) logs are attached in Microsoft Excel formats and have been released in full, with no redactions. The logs are from our Presidential Libraries and The National Declassification Center.

This concludes the processing of your FOIA request. If you are not satisfied with our action on this request, you have the right to file an administrative appeal within ninety (90) calendar days from the date of this letter via regular U.S. mail or email. By filing an appeal, you preserve your rights under FOIA and give the agency a chance to review and reconsider your request and the agency's decision.
