This is in response to your letter dated October 30, 2016, which was received in my office on November 7, 2016 for processing under the Freedom of Information Act (FOIA), 5 U.S.C. 552.

You requested a copy of the Office of the Comptroller of the Currency's (OCC) Freedom of Information Act Appeals Log since 2009.

Enclosed are the appeals log responsive to your request. Please note that the OCC has not received any appeals since July 2016.
