Hoover, Director of Special Staff, Defense POW/MIA Accounting Agency, has determined that some information must be withheld pursuant to 5 U.S.C. § 552 (b)(6), which pertains to information the release of which would constitute a clearly unwarranted invasion of the personal privacy of third parties.
