This letter is in response to your December 25, 2016, Freedom of Information Act (FOIA) request seeking "a copy or printout of the list of Education Department OIG investigations closed during calendar year 2015 and calendar year 2016."

The Office of the Inspector General (OIG) conducted a search and located four pages responsive to your request. We have withheld some information pursuant to Exemptions (b)(6) and (b)(7)(C) of FOIA, which protect personal privacy interests. The information withheld under Exemptions (b)(6) and (b)(7)(c) include names of investigation complainants and subjects, as well as investigator names.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. See 5 U.S.C. 552(c) (2006 & Supp. IV 2010). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.

This is the final response from OIG. If you are not satisfied with my action on this request, you may file an administrative appeal by writing within 90 days of the date of this letter to the:

A copy of your initial request, a copy of this letter and your statement of circumstances, reasons, and arguments should accompany your appeal letter.

You also have the right to seek assistance and/or dispute resolution services from the OIG FOIA Public Liaison or from the Office of Government Information Services (OGIS). The OIG FOIA Public Liaison is responsible, among other duties, for assisting in the resolution of FOIA

disputes. OGIS, which is outside of the Department of Education, offers mediation services to resolve disputes between FOIA requesters and federal agencies as a non-exclusive alternative to appeals or litigation.
