This letter responds to your December 25, 2016, Freedom of Information Act (FOIA)<sup>1</sup> request to the U.S. Department of Agriculture's (USDA) Office of Inspector General (OIG). You requested a list of OIG investigations closed during calendar year 2015 and 2016. You limited the scope of your request to investigations within the USDA and excluded investigations of external programs, such as food stamps.

We are releasing five pages of responsive records.

You have the right to appeal OIG's decision by writing to the Inspector General, U.S. Department of Agriculture, 1400 Independence Avenue SW., Whitten Building, Suite 441-E, Washington, D.C. 20250-2308. Your appeal must be received within 90 days of this letter. The outside of the envelope should be clearly marked "FOIA APPEAL."

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. See 5 U.S.C. 552(c) (2006 & Supp. IV 2010). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.

Pursuant to FOIA, you have the right to seek assistance from the OIG FOIA Public Liaison. You can also seek dispute resolution services from the FOIA Public Liaison or the Office of Government Information Services (OGIS).

As part of the 2007 FOIA amendments, OGIS was created to offer mediation services to resolve disputes between FOIA requesters and Federal agencies as a non-exclusive alternative to litigation. Using OGIS' services does not affect your right to pursue litigation. If you are
