Thank you for your Freedom of Information Act (FOIA) request dated September 10, 2017, and received in our office on September 11, 2017. Your request was assigned FOIA Case Number 17-LaRC-F-01126 and was for:

"A copy of the correspondence between NASA Langley and the producers of the award winning movie HIDDEN FIGURES (filmed in part at Langley Research Center). The subject of the requested correspondence is assistance by NASA for the movie and its filming, and arrangements for access to the NASA-Langley facilities. By producers, I mean Fox 2000 Pictures, Chernin Entertainment, and Levantine Films."

The NASA's Langley Research Center's Program Office conducted a search for records using the above criteria and located responsive records to your request. Those records are attached. NASA withheld from disclosure inter-agency/intra-agency emails and records that are attorney work-product pursuant to FOIA Exemption 5 U.S.C. § 552(b)(5). NASA also withheld predecisional deliberative process documents pursuant to FOIA Exemption 5 U.S.C. § 552(b)(5). NASA also withheld information that would constitute an unwarranted invasion of personal privacy (company addresses, email addresses, phone/mobile numbers, and fax numbers) that are specific to certain individuals pursuant to 5 U.S.C. § 552(b)(6).

FOIA Exemption 5 U.S.C. § 552 (b)(5), "... protects inter-agency or intra-agency memorandums or letters which would not be available by law to a party other than an agency in litigation with the agency."

FOIA Exemption 5 U.S.C. § 552 (b)(6), "... protects information about individuals in 'personnel and medical files and similar files' when the disclosure of such information "would constitute a clearly unwarranted invasion of personal privacy."

Since information is being withheld, you have the right under 14 CFR §1206.700 to appeal this initial determination within 90 days from the date of this letter. Your appeal must be in writing and should be addressed to:

Administrator NASA Headquarters Executive Secretariat MS 9R17 300 E Street, SW Washington, DC 20546 ATTN: FOIA Appeals

The appeal should be marked "Appeal under the Freedom of Information Act" both on the envelope and the face of the letter. A copy of your initial request must be enclosed along with a copy of the adverse determination and any other correspondence with the FOIA office. In order to expedite the appellate process and ensure full consideration of your appeal, your appeal should contain a brief statement of the reasons you believe this initial decision to be in error.

For your information, the Office of Government Information Services (OGIS) offers mediation services to resolve disputes between FOIA requesters and Federal agencies. 



RIDER TO PRODUCT LOAN AGREEMENT

Rider to Loan of NASA Equipment dated as of March 16, 2016 between TWENTIETH CENTURY FOX, a division of Twenfleth Century Fox Film Corporation ("Borrower") and NASA LANGLEY RESEARCH CENTER ("Lender") in connection with the theatrical motion picture currently entitled "HIDDEN FIGURES" ("Picture").

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Borrower and Lender agree as follows:

Paragraph 14. The phrase "or to withdraw the Borrower's authority to use the Equipment" is hereby deleted.

Borrower is not required to use the Product(s) in the Picture.
- B. <u>LENDER REPRESENTATIONS AND WARRANTIES</u>; Lender represents and warrants that (a) it is the sole owner of the Product(s) and of all rights necessary to grant to Borrower the Rights herein granted; (b) no other consents or approvals are required in connection with such Rights as contemplated by this Agreement; and (c) it is not necessary for Borrower to pay any amount to any person, firm or corporation (including without limitation Lender) in order to enable Borrower to enjoy the full rights to use the Product(s) as described herein.
- C. Borrower acknowledges that it has no ownership interest in the Mark(s) except to include it in the Picture and as otherwise provided herein. Nothing contained in this Agreement shall be construed as granting to Lender any ownership, license(s) or parmission(s) whatsoever in connection with any commercial use of the Product(s) in connection with the Picture, including without limitation, the title of the Picture, any character name(s), any actual name(s) and/or likeness(es) of any individual(s) rendering services of any kind on the Picture, or any other images, associations, and/or references.
- D. <u>CONFIDENTIALITY</u>: Lender (or any employee and/or agent of Lender) agrees not to, at any time, disseminate, publish, state or in any manner disclose any information of any kind dealing with the filming of the Picture.

Logistics does not pay to ship property. These costs must be paid by the borrower or by the program initiating the property loan. You guys will need to work out these details and provide Venita with a WBS. 


