This letter is in response to your Freedom of Information Act (FOIA) request received in the Office of the Chief Counsel – FOIA and Transparency Services on January 23, 2018 for a copy of all emails and letters between the Office of Inspector General and BEP in 2016. You specified that only two office's correspondence need be searched.

You were notified in our letter to you on January 31, 2018, that the BEP charges private citizens' fees related to the cost of duplication and for time spent in search after the first two (2) hours. The first 100 pages are duplicated without charge. However, a charge of \$.20 per page for standard duplication is charged for each page over 100. On February 21, you were notified of the Agency's need for an extension of time of ten (10) working days to complete the processing of the FOIA request. 5 U.S.C. 552(a)(6)(B).

Enclosed with no charge to you are the first 100 pages of the responsive documents. Pursuant to Exemption (b)(6) of the FOIA, we have withheld personal information, including social security numbers, home addresses, and personal telephone numbers, the release of which would constitute a clearly unwarranted invasion of personal privacy.

You agreed to pay \$25 associated with processing your request. There appears to remain approximately 600 pages of responsive documents. If you are interested in obtaining the remaining responsive documents, please mail your payment in the form of check or money order in the amount of \$120 payable to the Bureau of Engraving and Printing, to the attention of the undersigned Disclosure Officer. Please include the FOIA number on the check or money order. If we do not hear from you within thirty (30) days from the date of this letter, your file will be deemed closed and no further action will be taken on this request.
