This responds to your Freedom of Information Act (FOIA) request dated January 19, 2007, which was received in this Office on January 26, 2007, in which you requested FOIA Counselor notes from January 1, 2004 to the present. This response is being made on behalf of the Office of Information Policy.

As we explained in our letter dated February 27, 2007, we are processing FOIA Counselor notes from January 1, 2005 to January 31, 2007 for this request. Please be advised that a records search was conducted in this Office and approximately 1682 pages of responsive material has been located. Department of Justice regulations permit us to provide you, who we have determined to be a non-media, non-commercial requester pursuant to 5 U.S.C. § 552(a)(4)(ii)(III), with 100 pages of records without incurring duplication fees. <u>See</u> C.F.R. § 16.11(d) (2008). Duplication fees beyond one hundred pages will be assessed at ten cents per page. <u>See id.</u>

We have completed the processing, and copies are enclosed, of 130 pages that are responsive to your request. I have determined that these documents are appropriate for release with excisions made pursuant to Exemptions 5 and 6 of the FOIA, 5 U.S.C. § 552(b)(5) and (b)(6). Exemption 5 pertains to certain inter- and intra-agency communications protected by the attorney-client privilege. Although advice to callers from federal Department's and agencies are protected by the attorney-client privilege, some advice entries also contain attorney-work product and deliberative process privileged information as well. Exemption 6 pertains to information the release of which would constitute a clearly unwarranted invasion of the personal privacy of third parties. Some entries are being withheld as they contain information regarding litigation and contain deliberative discussion.

We estimate that there are an additional 1552 pages of records responsive to your request. I note that you have agreed to pay up to \$100 in fees. However, duplication fees for the remaining pages, as well as for the extra twenty-one pages enclosed, assessed at ten cents per page, will amount to approximately \$158.50. Accordingly, in order to complete the processing of your request, we must have your commitment to pay all of the applicable fees. Alternatively, you may specify a particular amount you are willing to pay, or you may wish to reformulate your request to reduce the amount of fees incurred. Please indicate your willingness to pay by signing and returning the attached sheet to the address stated in the last paragraph. You may also call

Erica Snyder at the above telephone number if you wish to discuss your request. If we have not heard from you within fourteen days from the date of this letter, we will assume that you are no longer interested in receiving the remaining pages and we will close your file in this Office.

If you are not satisfied with my response to this request, you may administratively appeal by writing to the Director, Office of Information Policy, United States Department of Justice, Suite 11050, 1425 New York Avenue, NW, Washington, DC 20530-0001, and your appeal must be received within sixty days from the date of this letter. Both the letter and the envelope should be clearly marked "Freedom of Information Act Appeal."



Questions: (1) How can I confirm that a third party is a fugitive from federal law enforcement? (2) How should the request be phrased, e.g., is so-and-so a federal fugitive?

Responses: (1) DOJ typically will neither confirm or deny the existence of law enforcement records about a third party, absence proof of death, overriding public interest, or waiver, pursuant to Exemption 7C. That said, I referred him to DOJ's website for FOIA contact information, and provided him with FBIHQ's mailing address I further advised him that if he wanted records maintained by FBI field offices, he would need to write to them directly Field office addresses available on FBI's website; (2) FOIA does not require agencies to answer questions, he should reasonably describe the records he seeks.
