This is the final electronic response to your October 30, 2007, Freedom of Information Act (FOIA) request to the Department of Homeland Security (DHS) for the DHS FOIA request logs for 2005, 2006 and 2007. Your request was received on November 14, 2007.

My December 3, 2007 response to your request advised you that our search pertained only to correspondence and associated documents issued and received at the DHS Privacy Office. You were also provided with copies of those FOIA logs that had been previously requested and released under the FOIA, to include the FOIA logs for Fiscal Year 2005, Fiscal Year 2006, and a partial log for Fiscal Year 2007 that covered the period from October 2006 through July 2007.

A search for additional records responsive to your request produced the enclosed FOIA log, which covers the period from July 23, 2007 to December 4, 2007. From the enclosed log, certain information has been withheld pursuant to the Freedom of Information Act, 5 U.S.C. §552 (b)(6), FOIA Exemption 6. Exemption 6 exempts from disclosure records the release of which would cause a clearly unwarranted invasion of personal privacy.

You have the right to appeal the above withholding determination. Should you wish to file an appeal, you must send it within 60 days of the date of our final response by writing to the following address: Office of the Associate General Counsel (General Law), U.S. Department of Homeland Security, Washington, D.C. 20528, following the procedures outlined in Subpart a, Section 5.9, of the DHS FOIA Regulations. Your envelope and letter should be marked "Freedom of Information Act Appeal." Copies of the Regulations are available at www.DHS.gov.

As the cost of processing your request fell below the \$14 minimum, there is no charge. Therefore, your request for a fee waiver is moot.
