This letter responds to your Freedom of Information Act (FOIA) (5 U.S.C. § 552) request, dated August 21, 2008, that was received in the Rural Development Utilities Programs FOIA office on September 5, 2008. You are requesting "a copy of the Rural Utilities Service FOIA Case Log for the years 2000 through present."

We are unable to locate FOIA case logs for fiscal years 2002-2005; therefore, we have no records responsive to this portion of your request. The FOIA case logs for fiscal years 2000, 2001, 2006, 2007 and 2008, consisting of 78 pages, are enclosed. Of those 78 pages, 75 pages are released in their entirety, and three pages have portions withheld pursuant to Exemption 6 of the FOIA.

Exemption 6, 5 U.S.C. 552(b)(6), permits the Government to withhold all information about individuals in "personnel and medical files and similar files," where the disclosure of such information "would constitute a clearly unwarranted invasion of personal privacy." Exemption 6 also involves a balancing of the public's interest in disclosure against the individual's privacy interest. We have determined that the name of the requester and subject information regarding investigations should be withheld pursuant to Exemption 6 of the FOIA.

Pursuant to Title 7 Code of Federal Regulations (CFR), Subtitle A, Part 1, Subpart A, Appendix A, there is no charge for the records enclosed as the amount falls below the minimum amount required for the Rural Development to collect fees.


