
- 1) a set of electronic/digital copies of the "all aboard" newsletter (all years).

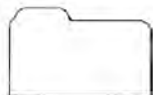
