This is in response to your letter, dated 12 August 2008, received in the Information Management Services Center (IMSC) of the National Reconnaissance Office (NRO) on 22 August 2008. Pursuant to the Freedom of Information Act (FOIA), you requested a copy of "the list(s) of periodic employee colloquia, brown bag lunch talks, and employee seminar duscussions..."

Your request was processed in accordance with the Freedom of Information Act, 5 U.S.C. § 552, as amended. A thorough search of our files and databases located 1 record, consisting of 1 page that is responsive to your request. This record is being released to you in full.

The FOIA authorizes federal agencies to assess fees for record services. Based upon the information provided, you have been placed in the "other" category of requesters, which means you are responsible for the cost of search time exceeding two hours (\$44.00/hour) and reproduction fees (.15 per page) exceeding 100 pages. In this case, no fees were incurred.

You have the right to appeal this determination by addressing your appeal to the NRO Appeal Authority, 14675 Lee Road, Chantilly, VA 20151-1715 within 60 days of the above date. Should you decide to do this, please explain the basis of your appeal.


