This is in response to your Freedom of Information Act (FOIA) request dated 22 Sept 08. We received your request via e-mail on 2 Oct 08 from HAF/IMII. You requested "a list of closed inspection or investigation Air Force Inspector General cases with a religious component." You noted that we could limit this request to all cases in the ACTS database from January 1, 2000 to the present.

Based on the written information provided, our record search included ACTS. The attached list is responsive to your request. In accordance with Air Force Disposition Schedule, T90-01, R 01.00, Inspector General records are destroyed two years after the year in which the case is closed. Therefore responsive records may not date back to year the 2000.

Under the FOIA, we are releasing to you the above mentioned list with redactions. The bases for this decision are exemptions (b) (6) and (b) (7) (c). Exemption (b) (6) requires withholding of information that, if released, would constitute a clearly unwarranted invasion of personal privacy. Similarly, exemption (b) (7) (c) requires withholding of records or information compiled for law enforcement purposes, where disclosure could reasonably be expected to constitute an unwarranted invasion of personal privacy.

You may appeal this decision in writing within 60 calendar days from the date of this letter. Your appeal must include the FOIA Case Number (09-0008), the reasons for reconsideration, and a copy of this letter. Please address your letter as follows:
