It should contain any information and argument upon which you rely. The decision of the Chief Counsel will be administratively final.

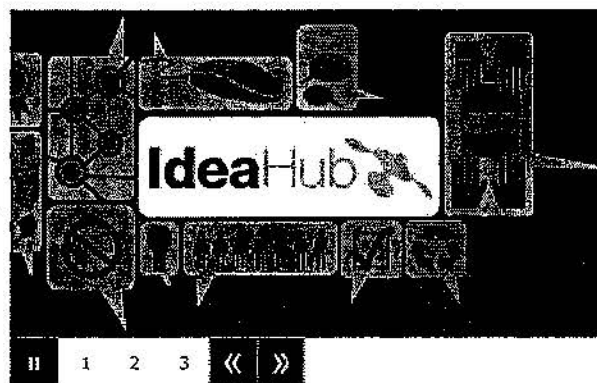

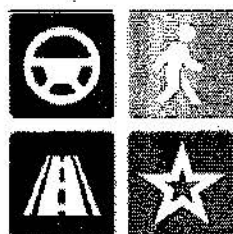

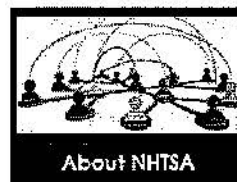
