This is in response to your request, under the Freedom of Information Act (FOIA), 5 U.S.C. § 552, dated October 30, 2016 and received on November 8, 2016, in which you requested a copy of the Freedom of Information Act Appeals Log for the NLRB for the time period since 2009 in electronic format. You agreed to assume financial responsibility for the processing of your request.

We acknowledged your request on November 8, 2016. An interim response was sent on November 9, 2016. We regret the delay in this response.

In a telephone conversation with a member of my staff on December 29, 2016, you modified your request to be seeking the following columns of information in the log: appeal number, requested material, date received and date closed.

I have attached a copy of the requested FOIA Appeal Request log. The document was generated using the Agency's FOIA Tracking System. Redactions have been made to portions of the requested document to protect the privacy interests of individuals named in the log. These redactions were made pursuant to FOIA Exemption 6, which pertains to information the release of which would constitute a clearly unwarranted invasion of personal privacy, and FOIA Exemption 7(C), which pertains to records or information compiled for law enforcement purposes, the release of which could reasonably be expected to constitute an unwarranted invasion of personal privacy. 5 U.S.C. § 552(b)(6) and b)(7)(C).

For the purpose of assessing fees, we have placed you in Category D, the "all other requesters" category, because you do not fall within any other of the fee categories. Consistent with this fee category, you will be assessed charges to recover the full reasonable direct costs for searching for the requested

documents and the duplication of those documents. As a requester in this category, you will not be charged for the first two hours of search time or the first 100 pages of duplication. NLRB Rules and Regulations, 29 C.F.R. § 102.117(d)(2)(ii)(D). Charges for all categories of requesters are \$3.10 per quarter-hour or portion thereof of clerical time and \$9.25 per quarter-hour or portion thereof of professional time. 29 C.F.R. § 102.117(d)(2)(i).

Less than two hours of professional time was expended in searching for the requested material. Accordingly, there is no charge for this request.
