

The Office of Government Ethics (OGE) is pleased to submit the enclosed draft bill "to amend the Ethics in Government Act of 1978, as amended, to streamline the financial disclosure requirements for Executive branch employees." We request that it be referred to the appropriate committee for prompt and favorable consideration.

This proposal, with one revision, would implement the recommendations we made in our April 2001 "Report on Improvements to the Financial Disclosure Process for Presidential Nominees" that was issued pursuant to Pub. L. 106-293, the "Presidential Transition Act of 2000." Upon further reflection, we are proposing as a revision to our recommendations to raise the minimum threshold for reporting assets to \$5,000 from the \$1,000 threshold that was established in 1978.

In our report, we determined that the public financial disclosure system could be improved substantially by amending the law upon which it is based. Specifically, we proposed that the Ethics in Government Act be amended to: reduce the number of valuation categories throughout; shorten certain reporting time-periods; limit the scope of reporting by raising certain dollar-thresholds; reduce descriptive details that are unnecessary for conflict analysis; and eliminate redundant reporting. It is important to note that we believe these recommendations are consistent with the mandate in the Transition Act not to lessen substantive compliance with any conflict of interest requirement.



On Wednesday and Thursday, April 4th and 5th, 2001, the Committee on Governmental Affairs will hold hearings on "The State of the Presidential Appointments Process." The purpose of these hearings is to analyze the process Presidential appointees currently have to undergo and accept recommendations for streamlining that process. As you know, the Presidential Transition Act of 2000, P.L. 106-293, directed the Office of Government Ethics to conduct a study and submit a report on improving the financial disclosure process required of presidential nominees under section 101(b) of the Ethics in Government Act of 1978. This study was requested in an effort to address growing concerns regarding the barriers to public service embedded in the financial disclosure requirements. It is our understanding that you will be ready to present the findings of your study, as well as recommendations to improve the process by which appointed individuals are scrutinized. It is our hope that you will testify at 10:00 a.m. on Thursday, April 5th, 2001, in Room 342 of the Dirksen Senate Office Building.

The Committee requests that you limit your oral presentation to five minutes, though a longer written statement may be submitted for the record. This will allow adequate time for you to respond to questions from Members of the Committee. Committee rules require that 100 copies of your prepared statement be submitted to the Chief Clerk by 10:00 a.m. on Tuesday, April 3, 2001 along with a copy of your testimony on a 3.5" diskette identifying the format of the file. We would ask that the copies of your written statement, the diskette, and a brief biography be delivered to: Darla Cassell, Chief Clerk, Committee on Governmental Affairs, United States Senate, 342 Dirksen Senate Office Building, Washington, DC 20510.
