You requested "a copy of the Mandatory Declassification Review (MDR) log maintained by the Department of the Treasury for the entire time period of the MDR Log (all years)." Your request has been processed under the provisions of the FOIA, 5 U.S.C. § 552. A reasonable search was conducted for records responsive to your request. A search for records resulted in locating one responsive document, totaling two pages. This document, which is enclosed, is released to you in full and without redaction.
