You requested:

The Bureau's Final Response to Your Request

We are writing you today to provide you with the Bureau's final response to your FOIA request consisting of 16 files (approximately 376 KB) being released to you in their entirety.

Fees – No Charge

We classified you as an "other-use" requester. As such, we may charge you for some of our search and duplication costs, but we will not charge you for our review costs; you are also entitled to up to 2 hours of search time and 100 pages of photocopies (or an equivalent volume) for free. *See* 43 C.F.R. § 2.39.

You also agreed to pay up to \$25.00 for processing each request. We do not bill requesters if, after taking into consideration your fee category entitlements, our processing costs are less than \$50.00, because the cost of collection would be greater than the fee collected. *See* 43 C.F.R. § 2.37(g). Therefore there is no billable fee for the processing of your request.
