This is the electronic final response to your Freedom of Information Act (FOIA) request to the Department of Homeland Security (DHS), dated June 18, 2018, and received by this office on June 18, 2018. You are seeking a copy of each email received by the email account CONGRESSTODHS during the time period June 1, 2018 to June 16, 2018. On February 5, 2020, via email, you clarified that your request would be satisfied if our office provided only the emails sent to this email address during the timeframe, and not the attachments to each email.

A search of Office of the Chief Information Officer (OCIO) documents responsive to your request produced a total of 138 pages. Of those pages, I have determined that 2 pages of the records are releasable in their entirety and 136 pages are partially releasable pursuant to Title 5 U.S.C. § 552: (b)(6) and (b)(7)(E), FOIA Exemptions 6 and b7(E).

Enclosed are 138 pages with certain information withheld as described below:

**FOIA Exemption 6** exempts from disclosure personnel or medical files and similar files the release of which would cause a clearly unwarranted invasion of personal privacy. This requires a balancing of the public's right to disclosure against the individual's right to privacy. The privacy interests of the individuals in the records you have requested outweigh any minimal public interest in disclosure of the information. Any private interest you may have in that information does not factor into the aforementioned balancing test.

**Exemption 7(E)** protects records compiled for law enforcement purposes, the release of which would disclose techniques and/or procedures for law enforcement investigations or prosecutions, or would disclose guidelines for law enforcement investigations or prosecutions if such disclosure could reasonably be expected to risk circumvention of the law. I determined that disclosure of law enforcement information could reasonably be expected to risk circumvention of the law. Additionally, the techniques and procedures at issue are not well known to the public.


You have a right to appeal the above withholding determination. Should you wish to do so, you must send your appeal and a copy of this letter, within 90 days of the date of this letter, to: Privacy Office, Attn: FOIA Appeals, U.S. Department of Homeland Security, 245 Murray Lane, SW, Mail Stop 0655, Washington, D.C. 20528-0655, following the procedures outlined in the DHS FOIA regulations at 6 C.F.R. Part 5 § 5.8. Your envelope and letter should be marked "FOIA Appeal." Copies of the FOIA and DHS FOIA regulations are available at [www.dhs.gov/foia](http://www.dhs.gov/foia).

Provisions of FOIA allow DHS to charge for processing fees, up to \$25, unless you seek a waiver of fees. In this instance, because the cost is below the \$25 minimum, there is no charge.

To whom it may concern,

I am writing to inquire if the Department of Homeland Security (DHS) is aware of (b)(6) who has been accused of running an orphanage in Haiti where he sexually abused boys, and if so, what actions have been taken to bring this man to justice.

This issue was raised to us by a constituent of ours who sponsored boys from Haiti who were abused at (b)(6)'s orphanage, (b)(6). She is claiming that she has worked with the Haitian government to produce an arrest warrant for M (b)(6) that caused him to flee to the Dominican Republic, where he has since started another home that she claims he is using to abuse boys. Regardless of Haitian law, she is also claiming he is in violation of U.S. law that prohibits United States citizens or legal permanent residents from traveling from the United States to a foreign country, and while there, raping or sexually molesting a child or paying a child for sex, or even simply traveling with the intent to engage in illegal sexual conduct with a child. I initially approached the Department of Justice's Child Obscenity and Exploitation Section (CEOS) to see what they knew about the issue or what they may be able to do, however they suggested reaching out to DHS.

Our constituent has provided us with an affidavit from a lawsuit in the State of Maine detailing Mr. (b)(6) primes that I would be happy to provide, and asked if we could facilitate a meeting between her and DHS to present what she knows, including the Haitian arrest warrant. I understand that this a complex “extraterritorial jurisdiction” issue, but after speaking with someone at CEOS, it sounds like this situation has unfortunately happened before and have been successfully prosecuted.

Please let me know if DHS has any updates on this situation or can recommend the best course of action that we can take to assist our constituent, including if she can meet with someone at DHS.



On June 13, Secretary of Homeland Security Kirstjen M. Nielsen met with Israeli Prime Minister Benjamin Netanyahu in Jerusalem during

the inaugural International Homeland Security Forum.

Secretary Nielsen thanked Prime Minister Netanyahu for his government's close cooperation with the Department of Homeland Security (DHS)

on a range of counterterrorism and public safety issues. This includes aviation security, border security, cybersecurity, emergency management, law enforcement, and science and technology research and development.

In addition to these efforts, Secretary Nielsen also highlighted actions DHS has taken to counter threats. These efforts include countering

the proliferation of nuclear, missile, and other technology; providing capacity building to our allies; and countering cyber threats. Further, Secretary Nielsen suggested that DHS and the government of Israel cooperate to advance implementation of United Nations Security Council Resolution 2396, which provides greater international focus on measures to address returning and relocating foreign terrorist fighters and transnational terrorist groups.

Secretary Nielsen traveled to Israel for the inaugural meeting of the International Homeland Security Forum. The purpose of the forum

is to improve countries' capabilities to face homeland and public security issues; deepen bilateral and multilateral cooperation; and share knowledge and best practices.
